## Party-Representative Ethics in International Arbitration:

There are fairly clear principles governing the conduct of an arbitrator, for example, the requirements of independence, impartiality, fairness and diligence. The parameters of ethical conduct on the part of a counsel or party representative in international arbitration are less obvious. Due to the diverse legal traditions in which party representatives are trained, there can be significant divergence in the expectations of how one should behave in an international arbitration. This lecture addresses some of the areas of controversies and proposes certain core ethical principles that should guide the behavior of party-representatives, wherever they come from and wherever the arbitration is seated.
